STOP CHLORAMINE (2025 NEW)

This polyvalent solid product, based on a strong oxidiser, aims to enhance and support chlorine-based or bromine treatments by regenerating the combined chlorine (also know as chloramines) into active chlorine without emptying the pool.

By its action, disinfectant consumption is reduced, and the bathers' health is preserved as chloramines are responsible for the notorious chlorine smell in pools and are known to trigger skin irritations (rash), nausea or dizziness.

By oxidizing dissolved organic particles, this product also contributes to clarify the pool and keep a crystal-clear water.

CALCIUM HYPOCHLORITE (also known as unstabilized chlorine or inorganic chlorine) is a powerful disinfectant. It has properties equivalent to chlorine without the addition of stabilizer. Over-stabilization eventually leads to a decrease in the effectiveness of disinfection.

Calcium hypochlorite is particularly well suited to rather soft and not very hard water. (low TH). However, it is advisable to use REVA OUT in hard waters.

REVA-KLORIT STICKS: the 300 g sticks are filmed. They are slow dissolving, thus ensuring the permanent disinfection of the pool.

REVA-KLORIT PELLETS: The pellets are used for shock treatment.

CAUTION: Calcium hypochlorite is incompatible with acidic products and all organic chlorines. When in contact with them, a toxic gas is released and the reaction can be explosive. **Never allow chlorine and hypochlorite to coexist in a skimmer or floating doser.**

WEEKLY DOSAGE:

For sticks: 1 stick per 25 m³ of water per week.

For the pellets: 75 g per 10 m³ to be diluted in a bucket at a rate of 15 g/L of water before pouring into the pool in front of the running discharges.

WATER BALANCE

As the driving factor of water's quality, pH should be regularly checked and adjusted between 7.0 and 7.4 to sustain the efficiency of the disinfection, to prevent scaling or corrosion, and to prevent over consumption of products. Bathers could also be exposed to eye or skin irritations. should the pH be uncontrolled.

Mareva only selects high-purity substances through a tough quality assurane; e process, to offer efficient and

easy-to-use solutions against unbalanced waters. pH and Total Alkalinity regulators are compatible with all treatments. filtration type or coating. As fine powders or small granules, they quickly dissolve into the pool. Treatments should be done with no bathers and continuously running filtration. pH adjustments should be made progressively and several hours apart, by injecting the required amount in several points of the pool or in front of the filtration backflow.

REVA-PLUS: PH ENHANCER

Dosage: Dose 100 gr per I Om' of water to increase the pl-I value by 0.1.

REVA PH+ ET TAC+: PH & TA ENHANCER

Usually, a decrease in pH go with a decrease in Total Alkalinity. This product increases simultaneously both parameters, reinforcing the waters' capacity to resist acidification (buffering capacity) and reducing corrosion. Dosage: 200 gr per IO rn³ of water to gain 0.1 pH unit.

A/ Return of goods: No return of goods (guaranteed or not) will be accepted without a return form and without the prior agreement of the Mareva company. In this case, a 20% discount will be deducted (with a minimum of €50) and the transport costs will be borne by the customer. He must keep the goods on his premises without being able to claim any compensation until receipt of this agreement. In case of acceptance, the return of the goods must be made to our warehouses, postage paid, and the credit note will be established for the value of the material minus 20% for administrative costs with a minimum charge of €50. Under no circumstances may the buyer return goods to Mareva freight collect, transport costs and any other return costs being the sole responsibility of the buyer, regardless of the reason for the return. We draw the customer's attention to his responsibility and duties during the return transport of dangerous goods. Only products packaged and over-packaged in their original packaging, insured by a transport logo or with similar efficiency may be handled by a carrier accredited for the transport of dangerous goods «ADR». Products returned unpackaged and not over-packaged in their original packaging will incur a repackaging fee.

B/ Warranty:

Unless otherwise specified, the warranty on our hardware is ONE YEAR from the date of delivery or availability. In accordance with articles 1625 and 1627 of the Civil Code, this guarantee is limited to the supplies of our Company. It consists of the repair by us, in our workshops, of manufacturing and material defects. Drop-off, rest, and transport costs are excluded from the warranty. Any additional guarantees granted or promised by the reseller are at his sole expense, the latter must be considered as a professional for the application of article 1645 of the Civil Code. As a matter of principle, a contract is binding only between the parties bound by the agreement; it is not transferable to other persons (Article 1165 of the Civil Code).

6- RESPONSIBILITY:

Mareva cannot be held liable for defects resulting from a fault on the part of the retailer in the advice, handling, conservation and storage of the products, in particular in the management of expiry dates. Our company cannot be held liable for any defects caused to the goods by the intervention of a third party, by the occurrence of a case of force majeure, by a use of the goods that does not comply with the stipulations of the instructions for use and/or precautions for use. In any case, our liability shall be limited to the replacement of defective parts without any compensation or damages being claimed for consequential or nonconsequential material and immaterial damage for bodily injury caused by the defective goods, unless the direct link between the damage and the goods is proven by the plaintiff. The warranty ceases when our equipment is modified outside our workshops. In the event that the customer has not

made the stipulated payments on the agreed terms, our guarantee will be suspended until the payment of the late instalments and without this suspension being able to increase the duration of the guarantee from the day of delivery. Water damage caused by the installation of water filtration or treatment systems located inside a building: the manufacturer's product liability insurance policy only covers these types of installation provided that the filtration system is installed on a casing with drainage pipes of sufficient cross-section to evacuate the water, even if the pump continues to operate on the day of delivery.

7 - CONDITIONS OF SALE:

Obtaining unfavourable information about the buyer (protested draft, unpaid bills) entitles us to refuse any order or to request an advance of funds or to apply payment terms different from those previously applied or applied to other customers. Mareva reserves the right to set a maximum outstanding amount for all or some of its clients, which it will communicate to them. Any order that entails a risk of exceeding the outstanding amount may be postponed or rejected.

8 -PAYMENT:

Invoices are payable according to the option chosen by mutual agreement. No invoice deduction may be unilaterally imposed by the customer due to a delay in delivery or non-compliant products without Mareva having had the opportunity to verify the objections and having given its consent. We do not accept any discount deductions for cash payment. In the event of payment by accepted drafts, these are published at the end of the month and must be returned signed within two weeks of their shipment. Failing this, the seller will be entitled to have a protest drawn up in the absence of acceptance. In the event of late payment, a late payment penalty calculated on the basis of the rate charged by the European Central Bank for its refinancing operations plus 10 points and a fixed indemnity for recovery costs of €40 will be payable, in accordance with Article L 441-6 of the French Commercial Code. In addition, Mareva reserves the right to suspend or cancel pending orders without prejudice to any other recourse. In the event of judicial recovery of the price of the goods, the sale price due by the buyer shall be increased by operation of law by 15% for recovery fees, without prejudice to damages in respect of costs. Any formal notice relating to a due date shall result in the payment of all unpaid invoices. Where the purchaser owes Mareva the balance of several similar deliveries, the partial payments which he has made may not be set off by him in settlement of special claims. It is up to Mareva to determine to which of these claims these partial settlements apply. The seller retains the right to refuse these.

9 - PENALTY CLAUSE:

Unless the deadline is extended by Mareva, any unpaid instalment will result in the contentious recovery of our debt and the application of a lump sum equal to 15% of the sums due, without prejudice to interest and surcharges for fees and damages for costs.

10 - RETENTION OF TITLE:

A/ Mareva reserves ownership of the goods shipped until full payment of the agreed price in accordance with the terms of Article 624-16 of the Commercial Code. Until full payment, without prejudice to our other rights above, we may, even in the event of receivership or judicial liquidation of the co-contractor, demand the return of our goods at the costs and expenses of the co-contractor, without any other formality than a formal

notice to return by registered letter with acknowledgement of receipt.

B/ The buyer must insure the goods against loss and damage and warn Mareva of any measures taken by third parties on the said goods, for example seizures carried out.

C/ In the event of non-payment of a single instalment, the return of the goods delivered may be claimed by Mareva and this claim may be made by any means: registered letter, contradictory inventory, bailiff's summons. D/ Mareva will keep as a penalty clause the advance payments that may have been paid, prior to the termination of the contract, which will occur automatically in the event of non-payment of a due date. In the event of resale and/or transformation by the buyer, the latter undertakes, at the seller's first request, to assign all or part of the receivables acquired from the sub-buyers, up to the amount still due.

11 - SECURITY OBLIGATIONS:

All persons who handle and/or store products must have training in handling and storage. Handlers should wear a chlorine cartridge mask, goggles and gloves during the operation.

12 - DELIVERY CONDITIONS:

Please note: Each reference has a price attached to it. All our deliveries are made in the packaging conditions indicated in our catalogue. Shipping costs are charged at the actual cost (contact us).
